Minutes for Annual Meeting of First Congregational UCC Sunday, May 5 2019

Call to order by Moderator Benjamin Uzzell at 11:22 AM. A quorum is met. Opening prayer by Rev. Jacqueline Perry. Blanket acceptance of the yearly reports was motioned by Steve Uzzell and 2nd by Tom McConnell. Motion carried.

Pastor's report was given by Pastor Jackie. She reported on the sheltering by our church to persons in need from Skyline Apartments after their fire. It brought up memories of our church fire in the 1940's. She reflected on memories of the past 5 years that will lead us into the future. We look especially forward to the 150th celebration next year.

Budget discussion and reports were given by Lori Williams. She requested the annual budget reflect a 12 month cycle and presented a printed report covering this time period. It shows the budget at \$4,676.31 less than last year. She suggested if everyone contributed \$100 per year more this year, we would make up that difference. We also need to see where we can cut expenses more to lighten an estimate of \$9,000 to have the woodwork scraped, painted, and sealed on the west side of the building. This money can come from the Madison County account to have that necessary work done. Jane Uzzell motioned and Scott Williams 2nd to use that payment. The motion carried. There was discussion that the church will need plans to replace the office copy machine as it is 12 years old and parts are no longer available for it. It was motioned that the money (\$4,500) be allotted when the time comes that a new machine is necessary. After much discussion, Stan Staab motioned to allow this purchase when the time comes that the current one breaks down. Jane Uzzell 2nd. To was carried by vote.

Lori Williams suggested that a business action team be established using a member from the other committees including the office and the Unity Council. (a total of 5-7 people) They would be an action team to help control the budget. They would report to the Support Ministry team. Vicki Staab made the motion and Scott Williams 2nd to set up this action team. Motion carried. Scott Williams motioned and Steve Uzzell 2nd to accept the budget Motion carried.

Ben Uzzell asked for a motion to adjourn. Scott Williams 2nd Motion carried. Meeting adjourned at 12:28 PM.

September 29, 2019

Tom McConnell lead the discussion about the request from LingJe Escogido. Lori shared that we were here to discuss this subject. She explained what they need and when they need it. Parking spaces were a topic of discussion. We could try the agreement we reach with them for 6 months and renegotiate all of it. We talked about meeting times, space, storage, finances, and other topics. A committee of Scott Williams, Randy Neuharth, Barb Koenig and Stan Staab will meet to work out a lease agreement. We will meet again October 13 to discuss again.

October 13, 2019

Stan Staab announced to the congregation that a lease agreement had been drawn up by the committee of Stan Staab, Scott Williams, Barb Koenig and Randy Neuharth with the assistance of lawyer Chuck Balsiger. It will be available in the church office for members to come in during the week and read. Please don't take it from the building as it is a legal document. We will vote on October 20, 2019 to decide whether to offer the lease to LingJe Escogido or not. Will absentee votes be accepted? No. We want the decision to be made that day. Votes will be counted by Mike Synovec, Verletta Olson and Stacie Uzzell. What will be the charge for rent? \$1,200 per month. We will use the agreement for a period of 6 months and then review it for any additions or necessary changes. We will deal with problems or concerns as they come up. The lease agreement was taken into Fellowship Hall and made available for members to read and then left in the office.

October 20, 2019

The congregational meeting was called to order by Stan Staab. Scott Williams presented the question before the congregation. "On the motion to enter into a lease with Lineje Escogido, a non-denominational church, I vote: yes or no." Randy Neuharth seconded the motion. Can we read the lease? A copy was given. Can we discuss before the vote? Yes. Will we be able to sue some of the rooms? Yes. Where will our Sunday School meet? Older ones in balcony and little ones move upstairs. Can we use kitchen when we need to? With advance notice. Scott Williams and Benn Uzzell joined Stan to answer questions. We will work out special events as time goes on. We will have a 6 month trial. If all goes wee, we will renew for one year. If need be, it will be cancelled. When will they begin? The lease currently says December 1, but they have some say to that. How will we control free reign of their use of the church? What about increased cost of utilities? Lori Williams stated that we will take on these situations as we learn and work with them. Steve Uzzell talked about others helping us when our church was in need, so this is our chance to be helpful with what God has given to us. Insurance overage is covered in the lease. The question was called. Verletta Olson, Mike Synovec and Stacie Uzzell will collect and count the votes and return with the results. 25 members are needed for a quorum. Enough people are present to vote. A hymn was sung while the counting was done. The results of the vote were: 33 yes votes, 1 no vote and 1 unmarked. Vote is passed in favor of the lease. Pastor Jackie said a prayer. Scott Williams made a motion to dismiss the meeting. Motion passed. Meeting adjourned. Dorothy Hull, Clerk

November 10, 2019

A Congregational meeting was held on November 10, 2019, at approximately 11:20 a.m., Moderator Stan Staab called the meeting to order. Steve Uzzell made a motion, seconded by Susan Surber, "I move to allow the church's lease committee to negotiate with Linaje Escogido a lease agreement with monthly rent no less than \$800 per month." Mike Synovec, Verletta Olson, and Stacie Uzzell were appointed to be the ballot counters. Moderator Stan read the ballot and then opened a time for guestions. He also explained that Randy Neuharth, Scott Williams, and himself, Stan Staab, had met with members of Linaje Escogido after the last congregational meeting which was held October 20, 2019. Rent of no lower than \$800/month will be reviewed 6 months after the lease takes effect and that Linaje Escogido will take over maintenance of the lower level. First Congregational UCC will ask Renner Cleaning to lower our cost of cleaning as they will be cleaning the upper level only. Linaje Escogido will pay 20% of snow removal costs. After 1 year, First Congregation UCC will do a look back at the cost of utilities. If the cost of utilities goes up more than 10%, Linaje Escogido will pay 10%. Discussion occurred. The vote was taken. Jill Waterbury, church organist, played, and the members sang, "How Firm a Foundation," while the votes were being counted. The vote was 28 For, 5 Opposed for the lease committee to negotiate with Linaje Escogido. At this time, December 1 is the proposed date for the lease term to begin. Both congregations have been invited to visit the other. Pastor Jackie Perry closed the meeting with prayer.

Pastor's Annual Report 2020

"God is our refuge and strength, a very present help in trouble." -Psalm 46:1

In Christian community, we share resources. Nearly one year ago in April, First Congregational sheltered our neighbors from Skyline Apartments due to a fire. We continued to support and encourage the 52 displaced people at Country Inn for 52 days, through visits, grocery gift cards, socks, and microwavable meals. In May, youth and adults planted flowers and veggies in Skyline's new garden boxes. In July, we celebrated with them through a youth ice cream social.

After two Congregational Meetings and much discernment, on December 1, 2019 First Congregational officially welcomed Pastors Abel and Araceli Garcia and members of their congregation, Linaje Escogido, a Spanish-speaking church who have operated many years in Norfolk. They now rent the space downstairs for worship, fellowship and classes. It is a joy to know that we are sharing the space that God has given us with others.

In October, our church hosted the Living Waters Association Fall Gathering where we could not only share our space, but practice hospitality to the wider church.

In Christian community, we share ministry. This past year our ministry partnerships have included: First Presbyterian, Trinity Episcopal, Linaje Escogido, and Westridge United Methodist Churches. We have collaborated on worship services, Vacation Bible School, Confirmation Class, community service, gift card donations and community events at Skyline Apartments, a Rescue Mission meal, and valentine-making for the Veterans' Home. We also united with Norfolk Area Ministerial Association through gift card donations, a community Prayer Service (after the floods), a Blue Christmas Service, and most recently tech sharing via ZOOM. Many reports within this *Annual Report* carry details about the ministries we share within the church.

In Christian community, we share our faith.

I write this report as the world is in the midst of a global pandemic (Covid-19). Even while practicing 'social distancing', our church continues to share their faith by sharing themselves through email blasts, calls, notes, giving, budgeting, maintenance, drive-through church, childcare, art, music, prayer, and planning our 150th anniversary celebrations. God is indeed our refuge and strength, a very present help in times of trouble. "Do not be anxious", Jesus says. We practice our faith so you may share it with the world.

AED (automatic external defibrillator) fund stands at \$355. Annual reports due April 15th. **9**th —Men's luncheon @ Barnstormers. Topic is major religions of the world. 10th—Book Club met @ 10 AM. Children's Book read was One Plastic Bag and the theme was changing trash to art. 13th — Easter Egg Hunt; held at First Congregational UCC sponsored by Trinity Episcopal, First Presbyterian, and FCUCC. Funded by Thrivent Financial. 14th—Palm Sunday. Monthly collection at our church for O'Neill UMC continued. 18th—Maundy Thursday service @ First Presbyterian Church. Supper @ 6:00 PM with worship @ 7 PM. **21**st — Easter Sunday. Easter lilies graced the altar and donated by several members. No fellowship hour. 25th — Skyline Apartments fire. Our church hosted residents who were displaced throughout the day. Those assisting with some type of help were Stan & Vicki Staab, Verletta Olson, Tom McConnell, Tim Ernst, Susan Allyn, Susan Surber, Terry Hamilton, Steve Uzzell, Chris Storm and neighbor Richard Sirois. **28**th — Worship. Conservation Sunday observed--especially important after this year's flooding. AED Fund stands at \$555. Only \$200 to go. Annual meeting reports handed out.

May 4th — Pastor Jackie and Norfolk Area Ministerial Association shared a time of prayer and support for the community and victims of the recent floods at First United Methodist Church. First Congregational UCC became the collection point for donations to aid those Skyline Apt. residents displaced due to the April 25th fire. In the end, 52 people were displaced for 52 days. Most folks were sheltered at Country Inn. \$2000 was raised by the following churches: First Congregational UCC, First Presbyterian, First Christian, Victory Road Assembly of God, Westridge United Methodist Church & Immaculata Spirituality Center. "Bridal Garden Shower" held for Jessica Boschen. She will marry Mike Kroeger on May 25, 2019. 5th — Holy Communion. Teacher Appreciation Sunday with Breakfast served to the teachers. Honored the following teachers & substitutes: Darlene Korthals, Bonnie Kroeger, Vicki Staab, Susan Allyn, Mike Synovec, Stan Staab, Tom McConnell, Steve & Jane Uzzell and Pastor Jackie. The annual meeting followed services with the annual report, budget presentation, election and installation of Council Officers. Stan Staab,

Moderator; Ben Uzzell, Past Moderator; Tom McConnell, Vice Moderator; Lori Williams, Treasurer; and Dorothy Hull, Clerk. Weekly 150th quilt block postings will appear on our Face book page, with a comment by each. 8th—Book Club met @ 9:30 AM. Book read was One Well: The Story of Water on Earth. The group traveled to Bloomfield for lunch @ The Hive, discussion on the book, sightseeing, and shopping. 9th — Nine people under the direction of Bonnie Kroeger volunteered to help plant flowers & vegetables in new garden boxes at the Skyline apartments. Those helping were Pastor Jackie, Dorothy Hull, Kennedy & Skylar Indra, Paige, Reese & Grace Uzzell, Henry Gamerl, and Michelle Indra. It was going to freeze that night so we carefully covered all the boxes and Bonnie Kroeger returned on Saturday and residents (who wanted to participate) helped finish planting the rest of the flowers. Men's luncheon @ Barnstormers. Discussion was on Christianity, The United Church of Christ. 12th —Worship. Mother's Day. Carnations were given to all nurturing women. AED Fund -- \$780. Goal reached. AED will be ordered. 19th — Worship. Blessings to new graduates: Garrett Korthals & Janell Feenstra—Northeast Community College and McKenna Waterbury— Creighton University. Still collecting donations for those residents displaced due to Skyline Apt. fire; instant foods, gift cards, taxi vouchers, clothing, new pillows, sheet sets and towels are needed. 25th — Mike Kroeger & Jessica Boschen were married in a 4 PM backyard wedding at 1508 Crown Road in the presence of their families. A reception was held afterwards. 26th — Memorial Day Weekend. Based on hunger. **17**th — Worship. New church directories are ready. **21**st —Men's Group met @ Pizza Hut. Trivia quiz by Mike Synovec. **24**th — Worship. Salvation Army is again collecting new pajamas for the pajama project and also monetary donations. **27**th — Thanksgiving Eve Service @ 6:30 PM at FCUCC, held jointly with First Presbyterian and Trinity Episcopal Church. All 3 ministers and the Confirmation Class participated, along with several members. **28**th — Thanksgiving, 2nd year for the Potluck hosted by Steve & Jane Uzzell serving turkey and ham. Those attending were asked to bring a dish to pass. Attendance was about 35.

DECEMBER 1st — Holy Communion. Advent sermon "Hopeful Joy". Linaje Escogido's church members sang "Come Now Is the Time to Worship" at the start of service. After our services several FCUCC members joined Linaje Escogido in the first worship service downstairs. Poinsettia's graced the altar during December in honor and remembrance of many. "Hanging of the Greens" after worship, followed by soup and cookies. "Mitten Tree" is set up and collected donations of mittens, hats, gloves, socks, sweatpants and coats for Washington Elementary School. **7**th — Christmas Program practice at 10 AM with full dress rehearsal. **8**th — Worship. Sermon "Loving Joy". Treasurer's Annual Report 2020

Balance Sheet

In an effort to better reflect the assets of the church, the following items were added to the Balance Sheet as of March 31, 2020:

- 1) Memorial Account
- 2) Fixed Assets including the church & storage buildings and personal property at both locations based on the current value of insurance included on our Commercial Insurance policy
- 3) Scholarship Fund held at Edward Jones
- 4) Restricted Endowment Fund held at Edward Jones

Profit & Loss Prev Year Comparison

Office Copier:

At last years' annual meeting, there was discussion about replacing the 12 year old office copier. \$4500 was allotted for the purchase. The copier was replaced this year however instead of purchasing a new machine, we leased a copier for \$69/month for a total yearly expenditure of \$828. Currently that amount has been included in the expense category 514.003 Bulletins & Newsletters. Beginning in April 2020, a new expense category will be included - Lease of Equipment - for the copier lease.

*\$**8,800** was expensed in 2020 for the painting of the windows - money was transferred from the Madison County Bank account from a gift received in 2019

*\$1,625 was expensed in 2020 for scholarship payments received in 2019 but not transferred to the scholarship fund until 2020 Since the items were expensed in 2020, they add to the total loss of \$13,260.24. Had they been expensed in 2019 – the same year funds were received – the total loss for the year would be closer to \$3,000.

Proposed By-law changes

Treasurer: The Treasurer shall serve as one of the 5 members on Support Team.

A Treasurer shall be elected at each annual meeting for a term of one (1) year, renewable each year. The Treasurer shall receive all money of the church, give receipts for it, and deposit said funds as appropriate. On order from the Support Ministry he or she shall pay all bills of the church. He or she shall keep accurate account of alt receipts and disbursements and give bond as the Support Ministry may prescribe. The Treasurer shall keep a separate account of all benevolence, memorial and endowment funds. As one of the 5 members on Support Team, the Treasurer shall meet with the Support Ministry at their regular meetings. The chair of the Support Ministry shall serve as the Assistant Treasurer and perform all duties of the Treasurer in his or her absence.

2. Support Ministry:

The Support Ministry Team shall consist of five (5), 4 appointed and 1 elected as the Treasurer. Appointed members will serve a term of no-limits, the Treasurer will serve a term according to the term limits for that position. Because they are appointed, there is no need to vote any of the members onto the Support Ministry Team. The Support Ministry shall have the care and custody of the property of the church. The Support Ministry shall have no power to buy, sell, mortgage, lease or transfer real or personal property without a specific vote of the congregation authorizing such action. The Support Ministry shall review this section of the Constitution at its meeting falling three months prior to the annual meeting each year and make any recommendations for amendment of the same to the Unity Council for their consideration at the Unity Council's next meeting.

The Support Ministry Team shall have the following specific powers and duties:

- (a) To elect from its members a chairperson, a secretary, and a Unity Council representative. The Support Ministry shall meet monthly and three (3) members of the Ministry shall constitute a quorum. The Chair of the Support Ministry may sign all necessary or required legal documents on behalf of the church as the same have been authorized and approved by either the congregation or Unity Council ONLY in the absence of the Moderator or upon the Moderator's request. These documents may include, but shall not be limited to: promissory notes, line-of-credit documents, mortgages, deeds of conveyance of real estate, bills of sale for the conveyance of personal property, and contracts or other agreements affecting the church.
- (b) Be in charge of the receipt and expenditure of the funds of the church through the handling of the church Treasurer.
- (c) To provide for the raising of funds required by the church budget.
- (d) To arrange an annual church stewardship drive and canvass.
- (e) To propose an annual church budget and submit the same to the Unity Council for its review at its meeting one month prior to the annual meeting each year.
- (f) To oversee that the funds of the church are collected and expended by all church employees, agents, ministry teams, and by the Pastor pursuant to the budget—adopted by the congregation.
- (g) To review all special and permanent funds of the church.
- (h) To conduct a church audit/compilation at least once every three (3) years or whenever there is a change in the office of church treasurer.
- (i) To act as Personnel Action Team to hire and deal with issues pertaining to the employment of office administrator, custodian and other church employees, except pastoral and music staff.

The Support Ministry Team shall have the authority to expend sums up to \$7,500.00 over the amount budgeted therefore or for items not provided for in the budget, provided, however, the expenditure of any sum over \$7,500.00 shall not be made until the same is approved by the congregation at a duly called meeting pursuant to this Constitution and By-Laws.

Income from loose offerings, the Sunday school, rentals, and income from permanent funds shall be applied as directed by the Support Ministry Team, subject to the above provisions.

The Support Ministry Team is authorized to appoint Action Teams, in such number as it may deem advisable. These Action Teams will do the work of the church as directed by the Support Ministry Team. If a Financial Action Team is appointed, it shall take charge of pledges and loose offerings, pledges given or paid at any time, keep accurate record thereof, credit the identifiable funds to the individuals giving such funds in the account or accounts designated as the depository by the Support Ministry Team.
